## ***Message from Sheriff William L. King Jr.***

The York County Sheriff's Office is a special place to be a law enforcement officer. Rural patrol has unique challenges that force officers to think on their feet, make quick judgements, and become experts in time management. It is not easy.

The sheriff's office allows each deputy opportunities for professional growth through training but primarily through work experience. We promote proactive law enforcement and honor those who fill up their discretionary time enforcing traffic laws, patrolling hot spots and conducting follow-up investigations.

I have often said that our deputies are uniformed detectives, counselors, and in many instances, supervisors because the demands of the job as well as the vast patrol area allow our deputies to work independently. Consequently, we seek those individuals who are self-motivated and desire to be part of a group of individuals who are committed to improving the quality of life for our community members.

I find it an honor to be the sheriff of an organization with dedicated professionals. We consistently have a higher crime clearance rate and recover more stolen property than the national average. A deputy is allowed to be as "good" as he or she wants to be!

We have specialties like K-9, SRT, Honor Guard, etc. that you will find in this brochure but in my opinion, everybody has an individual specialty, and I challenge you to join this great organization where you are not just a number, but a member of our law enforcement family.



# Our Agency

The York County Sheriff's Office is located at 1 Layman Way in Alfred, Maine. This law enforcement agency is staffed by the Sheriff, Chief Deputy, two Majors, one Detective Sergeant., four patrol Sergeants, two detectives, and eighteen patrol deputies. The agency also employs one civil deputy supervisor and two full-time civil deputies. The York County Sheriff's Office employs two part-time deputies who work court security at the York County Superior Court building. These deputies mainly provide security for probate and other government officials located in the courthouse. The department has a civilian staff that consists of an administrative assistant, an administrative clerk, and two civil clerks. We also employ a mechanic and IT employee. The mechanic and IT worker are shared with the jail.

The York County Sheriff's Office utilizes the Sanford Regional Communications Center for dispatch services. The two Major positions are divided into two divisions, patrol and administrative. The patrol major is responsible for all patrol functions while the Administrative Major is responsible for training, staffing, certifications, equipment purchases, future planning, etc. The York County Sheriff's Office Criminal Investigation Division consists of a Detective Sergeant and two Detectives. One of the detectives is assigned as a Domestic Violence Investigator from a grant provided by Caring Unlimited. Our detectives are also responsible for maintaining the sex offender registry for all individuals residing in York County. We also have two School Resource Officer's that fall under our CID Division as well as a Task Force Officer assigned to the Maine Drug Enforcement Agency.

The York County Sheriff's Office has several specialty positions that our deputies can be involved in. We have three deputies trained as Peer Leaders for not only our agency but departments throughout York County. The York County Sheriff's Office received a grant from the National Alliance on Mental Health (NAMI) to spearhead this program in York County and it has been a resounding success so far. The York County Sheriff's Office also has a K-9 team, an Honor Guard Unit, Accident Reconstructionist, Crime Scene Mapper, Firearms Instructors, MARC instructor, negotiator and three deputies assigned to the Southern Maine Special Response Team.

The York County Sheriff's Office is part of the York County Government which consists of a County Manager and five elected County Commissioners. The County Manager is the Chief Administrative Officer for County Government and oversees the day-to-day operations of all York County Government Departments. The County Commissioners are elected to four-year terms and serve as the chief policy-making board of the county of York. These five commissioners represent the 29 cities and towns in York County.

The York County Sheriff's Office is an accredited police department with the Maine Law Enforcement Accreditation Program.

- ★ APPOINT A DEPUTY TO SPEARHEAD A STRONG AND DYNAMIC RECRUITMENT STRATEGY.
- ★ CONTINUE TO UTILIZE SOCIAL MEDIA PLATFORMS TO HIGHLIGHT THE YORK COUNTY SHERIFF'S OFFICE AND TO PROMOTE THE AGENCY AND ITS WORK IN OUR COMMUNITY.
- ★ START TO UTILIZE SOCIAL MEDIA PLATFORMS NOT CURRENTLY BEING USED BY THE SHERIFF'S OFFICE, SUCH AS INSTAGRAM, YOU TUBE, X (FORMERLY TWITTER), AND WHATSAPP.

THE FACILITY, WHICH IS BEING BUILT NEXT TO THE SHERIFF'S OFFICE WILL PROVIDE AN EXCELLENT OPPORTUNITY TO CONNECT WITH CRIMINAL JUSTICE STUDENTS INTERESTED IN A CAREER IN LAW ENFORCEMENT.

## Communities We Patrol



York County is the south westernmost county in the State of Maine. It was founded in 1639 and is the oldest county in the state of Maine and one of the oldest in the country. The 2020 census has the entire population at 211,972. This makes it the second most populated county in the state of Maine. The land area of our patrol area is comprised of residential, mixed-use, commercial, industrial, and farming. We have several major highways/roads that connect cities or are routes of travel for thousands of tourists every year. Rt. 111 connects Biddeford and Sanford, while Rt. 1 is also a busy highway that connects Kennebunk to the Biddeford area.

The York County Sheriff's Office and the Maine State Police have a call-sharing agreement involving the 14 York County towns that do not have a full-time police department. The York County Sheriff's Office has primary patrol in the following towns: Newfield, Waterboro, Acton, Shapleigh, Lebanon, Alfred, Lyman and Arundel. The total population of these towns is 34,086. The total square mileage is 321.4. It should be noted that these towns' population grows expediently in the summer months.

The York County Sheriff's Office presently has contract deputies assigned to the following towns, Waterboro (two deputies), Arundel (two deputies), and Acton-Shapleigh (one deputy). The same deputies are assigned to work in these communities for 40 hours per week and develop a close working relationship with these community members and stakeholders.

# Vision Statement and Core Values



The York County Sheriff's Office attempts to recruit and hire those individuals that best exemplify our vision statement and core values. We recognize that we have an awesome responsibility to our community members, business owners, and visitors to our county. Because of this responsibility, we strive to only hire those individuals whose core mission is public service.

Candidates go through a comprehensive hiring process to ensure we are hiring the best deputies to protect and serve our community. Our hiring process includes:

- ★ Oral Board Panel Interview
- ★ Background Investigation
- ★ Physical Aptitude Test
- ★ Polygraph Examination
- ★ Psychological Examination
- ★ Medical Screening
- ★ Sheriff's Interview
- ★ Completion of the Maine Criminal Justice Academy (or a waiver from another state)
- ★ Completion of the Field Training Program (360 hours for new recruit, 160 hours for experienced officer).



## Lateral Transfers

We do accept lateral transfers who are in good standing with their previous police department. The applicant is still mandated to complete the full hiring step process excluding the Maine Criminal Justice Academy with a proper waiver. The waiver process is based on the previous police academy they attended and if it aligns with the standards set forth by the Maine Criminal Justice Academy. An abbreviated Field Training Program is still required and will be based on the experience of the officer.



## **Trainings and the Maine Criminal Justice Academy**

York County Deputies attend numerous in-service training courses during the year that are required by the Maine Criminal Justice Academy. Deputies also are allowed to attend other training courses that they volunteer for or are part of their specialty position. Many of the specialties that deputies are involved with require a number of in-service training hours to maintain their certification.

### ***The mandatory required training for 2024 was:***

Use of Physical Force, Police Pursuit, Domestic Violence, Hostage or Barricaded Subject Incident, Response to Mental Illness, Involuntary Commitment & Protection from Substantial Threats, Violations of The Maine Civil Rights Act/ Hate or Bias Crimes, Recording of LE Interviews of Suspects & Witnesses, to Include Cases of Murder & Class A, Class B & Class C Crimes and The Preservation of Investigative Notes and Records in Such Cases, Public Notification Regarding Persons in The Community Required to Register under 34-A, Charters 15 & 17 Community Sex Offender Notification for Title 34-A, Chapters 15 and 17, Citizen Complaint, Criminal Conduct by a Law Enforcement Officer, Death Investigation, Unmanned Aerial Vehicles (only if your agency has a UAV), Bias-Based Profiling, and Execution of Unannounced Search Warrants.

Other training during the year that deputies take part in is firearms qualifications (twice a year), New Law-Case Updates, Responding to Mental Health Calls, Responding to Domestic Terrorist Threats, 4 hours of MARC training, and 20 hours of elective trainings.

All new recruits must attend and successfully pass the Maine Criminal Justice Academy Basic Law Enforcement Program. This program consists of a total of 720 curriculum hours on a number of different topics that are important to becoming a professional and proficient law enforcement officer.



## **FUTURE OUTLOOK**

The York County Sheriff's Office currently has two patrol deputy openings. Several patrol deputies are eligible to retire in the next few years, so there will be a need to attract qualified applicants to our agency. In order to remain one of the premier police agencies in Maine, we will need to continue to keep a highly competitive benefits package along with continued career development with training and educational opportunities.

We recognize that policing in a rural environment presents a number of unique challenges that an officer might not experience in a city agency. We are looking for that individual that is self-motivated and can make decisions under stressful conditions without always having the luxury of having a supervisor with you. This is not for everyone, but for those that enjoy challenges and have a strong desire to serve your community, we feel the York County Sheriff's Office is the place for you.

We are also very excited about the new state-of-the-art first responder training facility that is currently being constructed on our property. This facility is going to offer on-site training and equipment that we never thought possible. We are thrilled at the possibilities this will offer our patrol deputies with their career development. We are also confident that this will help retain the staff we currently employ and get us back to full strength in our patrol division.



The York County Sheriff's Office will continue to create a culture where problem-solving and innovation is rewarded, while making sure we only hire high character, ethical, and community-oriented individuals. We recognize that our community expects a professional and ethical police agency, and that is what we will give them. We look forward to what 2025 and beyond will bring for our communities and our agency.
